



Per Dose Cooled Semen Sales Agreement

This Cooled Semen Sales Agreement (the “Agreement”) is entered into as of _____ by and between Hilltop Farm, Inc., a Maryland corporation with its principal place of business at 1089 Nesbitt Road, Colora, MD 21917 (“Hilltop”) and the breeder listed below (“Breeder”).

1. The Breeder wishes to purchase semen from the following stallion (the “Stallion)

This stallion has tested positive as a carrier for Warmblood Fragile Foal Syndrome (WFFS) and is only available for breeding to mares that have tested negative for the WFFS gene. Documentation of negative status must be provided.		

3. **FEES AND ADMINISTRATION:** (a) Hilltop agrees to provide to the Breeder one dose of cooled semen from the Stallion (the “Semen”) for \$ 750, payable in U.S. Dollars. Upon payment of the Breeding Fee the Breeder is entitled to one dose of semen from the Stallion during Hilltop’s 2019 breeding season.

(b) The breeding season for the Stallion via cooled semen is April 10, 2019 to July 3, 2019.

(c) Cooled semen may not be frozen for future use, and semen provided under this Agreement may not be used to breed any mare other than the Mare identified in this Agreement. The Mare Owner assumes the risk of missed breeding opportunities due to problems with timing of the Mare’s ovulation, the Mare’s fertility, shipping or handling of the semen after it leaves Select Breeders Service, Inc. (“SBS”).

(b) The Purchase Price includes only the purchase of the semen. Any additional costs of transport of the Semen to the Breeder, and other expenses of breeding are over and above the Purchase Price.

4. **COLLECTION AND SHIPPING OF SEMEN.** (a) Collection and shipment of semen for Hilltop stallions is performed by Select Breeders Service, Inc. (“SBS”).

(b) Hilltop requires that the Breeder provide valid credit card information for securing the semen shipping container deposit and for any collection and shipping fees. These fees are payable to SBS prior to the shipment of semen via the Mare Owner’s credit card at the published SBS rates at the time of shipment.

(c) Semen is shipped in specialized containers which shall at all times remain the property of Hilltop or SBS. The shipping container must be returned to SBS in good condition within the timeframe listed on the container and by the method specified in the container documents. A Late Fee, as set out in the Schedule of Breeding Fees, may be assessed for late return of the shipping container. Any loss of or damage to the container will be the responsibility of the Breeder and will be charged to the Breeder’s credit card.

(d) Semen is typically available Sunday through Friday (*no collections on Saturday*). At rare times a stallion is given a “day off” from the breeding shed in order to insure optimal quality semen. Please keep Hilltop notified as the Mare enters her breeding cycle. Whenever possible semen is shipped overnight via Federal Express.

(e) **Requests for semen must be made by 9PM Eastern Time of the day preceding collection and shipment or pick-up, with the exception of Sunday collection requests which must be made by 5PM Eastern Time on Saturday. ALL requests for semen shipments must be made via TELEPHONE. Late notifications will be accommodated if possible, but there will be an additional late fee assessed by SBS.**

5. **NUMBER OF BREEDINGS.** The Breeder may produce only one foal from the Semen, from the Breeder’s mare identified below (the “Mare”). Upon submission to Hilltop of properly executed Mare Passport signed by a licensed veterinarian and indicating that a mare has been bred with the Semen, Hilltop will issue the appropriate Breeding Certificate.

Any disputes arising hereunder shall be resolved first by mediation before a mediator familiar with both the applicable law and the customs and practices of the equine industry.
