Incoming Requirements

Maryland State Requirements: All horses must be tested annually for Equine Infectious Anemia (Coggins Test) and obtain a veterinary health certificate within 30 days of transporting a horse across the state line.

Hilltop Requirements: Hilltop requires the following for any horse coming onto Hilltop's property. **All paperwork should** be on file <u>prior</u> to the horse's arrival.

- Negative Coggins dated within 12 months of your last scheduled day at Hilltop
- Flu/Rhino Vaccination Certificate within 180 days of your last scheduled day at Hilltop but not closer than 7 days prior to arrival
- For Stallions Negative EVA Titer & Vaccination History

 All stallions 30 months and older must be tested negative for Equine Viral Arteritis (EVA) within 30 days prior to arrival or provide proof of initial negative titer and subsequent annual vaccinations.
- Horse Emergency & Consent page 2. Only required if horse is stabling at Hilltop.
- Liability Release/ Personal Emergency & Consent page 3-4. Anyone assisting with riding or general horse care must complete.

Facility Use Information

Dogs: Please leave your canine friends at home.

Stabling: Limited stabling is available as space permits and may be in the Main Barn or surrounding barns. Bedding, stall mucking, grass hay, and night check are included in the stabling fee.

Feeding: It's easiest for Hilltop to provide/feed our grass or alfalfa hay due to our barn set-up. If you prefer to bring your own hay, please let us know ahead of time to ensure a storage location is ready. Grain should be in individually labeled, Ziploc bags for each feeding. **Events (inspections, stallion test, etc) may not include feeding of grain (see event specific emails/notes).** Please contact your Hilltop representative for clarification if needed.

Wash Stall: Guest wash stalls are available for your convenience for tacking, untacking, hosing-off, etc. Please check in with a Hilltop staff member for availability before use.

Turnout / Hand-Grazing: Please be aware <u>no turnout</u> is available for short-term boarding horses. Hand-grazing is available beyond the Main Barn's outdoor arena. Please do not hand-graze your horse in any other locations around the Main Barn.

Equipment Storage: Tack and equipment may be stored in our storage room directly off the octagon or in other designated areas. Please do not leave equipment in the wash stalls or in front of the stalls overnight, as our cleaning crew needs access early in the morning.

Trailer Parking: Trailer parking is available in front of the Conference Center (adjacent to SBS) or at the front of the property in the gravel lot next to the maintenance shed.
